Lock Replacement: Charge for lock replacement or rekeying residential lock.	Up to \$125	Per occurrence	Situational
Non-Sufficient Funds (NSF): Charge for returned payments due to non-sufficient funds.	\$25	Per occurrence	Situational
Parking Lost Permit Fee: Fee for parking permit replacement.	\$50	Per occurrence	Optional
Pet / Animal Violation Fee: Fee issued for unauthorized pets or violations of pet policy.	Varies	Per occurrence	Situational
