<b>Garage Structure (Parking Rent):</b> Charge for access to a garage space in large parking garage structure.	\$135 - \$200	Per item / month	Optional
<b>Pet Deposit (Refundable):</b> Deposit to cover any pet-related damage.	\$250	Per pet / one-time	Optional
<b>Pet Fee (Non-refundable):</b> Fee for allowing pets in the home.	\$250	Per pet / one-time	Optional

<b>Situational Fees</b>		<i>The below costs are situationally based.</i>	
<b>Access Card Fee Replacement:</b> Charge to replace lost or damaged key, fob, remote, or lost parking permit.	\$100	Per occurrence	Situational
<b>Concession Repayment:</b> Tenant repayment of rent discounts if lease terms are not met.	Varies	Per occurrence	Situational
<b>Early Lease Termination Fee:</b> Fee for ending lease agreement before its scheduled end date.	2 x rent	Per occurrence	Situational
<b>Improper Notice Fee:</b> Charge for not providing proper advance notice before move-out.	Varies	Per occurrence	Situational
<b>Transfer Unit Fee:</b> Charge for transferring to another home within the same community.	\$500	Per occurrence	Situational
<b>Late Fee:</b> Penalty for rent or fee payments made after the due date.	\$75	Per occurrence	Situational

<b>Legal / Eviction Fee:</b> Costs associated with an eviction proceeding.	Varies	Per occurrence	Situational
<b>Lock Replacement:</b> Charge for lock replacement or rekeying residential lock.	\$35 - 125	Per occurrence	Situational
<b>Non-Sufficient Funds (NSF):</b> Charge for returned payments due to non-sufficient funds.	\$25	Per occurrence	Situational
<b>Parking EV Charging:</b> Fee for on-site electric vehicle charging access.	\$175-\$250	Per vehicle / charge	Situational
<b>Reletting Fee:</b> An expense associated with re-renting a unit after early lease termination.	Varies	Per occurrence	Situational
<b>Renter's Insurance Non-Compliance Fee:</b> Fee for not maintaining required renter's liability insurance coverage.	\$50	Per occurrence / month	Situational
<b>Security Deposit Additional (Refundable):</b> Extra refundable deposit for added risk, damages, or lease conditions.	\$350	Per unit / one-time	Situational
<b>Smoking Violation Fee:</b> For non-compliance with community smoking policy.	Up to \$500	Per occurrence	Situational
<b>Trash Violation Fee:</b> Charge for non-compliance of community trash policy.	\$25-\$50	Per occurrence	Situational
<b>Vacant Cost Recovery (Utility):</b> Utility costs incurred while the unit was occupied by resident.	Usage-based	Per occurrence	Situational
