Application Fee: Fee to process rental application and background check.	\$54	Per application / one-time	Required
Security Deposit (Refundable): Refundable deposit covering potential damages and unpaid rent per lease terms.	\$500-\$600	Per unit / one-time	Required

Pest Control: Regular pest prevention and treatment services.	\$2	Per unit / month	Required

Renter Liability - Third Party: Expense related to required liability coverage through a third-party provider. Varies Per unit / month **Required**

Add Ons / Supplemental

The below costs are supplemental or needs based.

Amenity / Clubhouse Rental Fee: Fee for reserving the community clubhouse for events or gatherings. \$100 Per hour / occurrence Optional

Garage Structure (Parking Rent): Charge for access to a garage space in large parking garage structure. 1st Vehicle Free Per item / month Optional

EV Reserved (Parking Rent): Fee for a designated EV parking spot on site. \$175 Per vehicle / month Optional

Additional Space (Parking Rent): Charge for additional parking space on site. \$75-\$150 Per vehicle / month Optional

Parking Permit Fee (Reliant Parking): Fee for parking permit registration with Reliant Parking. \$25 Per vehicle / year Optional

Pet Deposit (Refundable): Deposit to cover any pet-related damage. \$500-\$750 Per pet / one-time Optional

Pet Rent: Monthly charge for keeping a pet in the home. \$50 Per pet / month Optional

Pet Screening Fee: Fee paid to PetScreening for pet profile management (*Fee waived for assistance animals*). \$30 Per pet / year Optional

Storage Rent: Fee for an on-site storage unit. \$50-\$125 Per Storage / month Optional

Situational Fees

The below costs are situationally based.

Access Card Fee Replacement: Charge to replace lost or damaged key, fob, remote, or lost parking permit. \$75 Per occurrence Situational

Concession Repayment: Tenant repayment of rent discounts if lease terms are not met. Varies Per occurrence Situational

Early Lease Termination Fee: Fee for ending lease agreement before its scheduled end date. 200% Per occurrence Situational

Improper Notice Fee: Charge for not providing proper advance notice before move-out. Varies Per occurrence Situational

Transfer Unit Fee: Charge for transferring to another home within the same community. TBD Per occurrence Situational

Non-Sufficient Funds (NSF): Charge for returned payments due to non-sufficient funds.	\$25	Per occurrence	Situational
Parking Lost Permit Fee: Fee for parking permit replacement.	\$25	Per occurrence	Optional
Parking Violation Fee: Fee for non-compliance with lease terms or community policies related to parking.	Varies	Per occurrence	Situational
Parking EV Charging: Fee for on-site electric vehicle charging access.	Varies	Per vehicle / charge	Situational
Pet / Animal Violation Fee: Fee issued for unauthorized pets or violations of pet policy.	Varies	Per occurrence	Situational
Renter's Insurance Non-Compliance Fee: Fee for not maintaining required renter's liability insurance coverage.	\$50	Per occurrence / month	Situational
Security Deposit Additional (Refundable): Extra refundable deposit for added risk, damages, or lease conditions.	Additional \$500	Per unit / one-time	Situational
Smoking Violation Fee: For non-compliance with community smoking policy.	Varies	Per occurrence	Situational
Trash Container Replacement: Charge for replacing a lost, stolen, or damaged trash bin.	\$50	Per occurrence	Situational
Trash Violation Fee: Charge for non-compliance of community trash policy.	\$25	Per occurrence	Situational
Vacant Cost Recovery (Utility): Utility costs incurred while the unit was occupied by resident.	Usage-based	Per occurrence	Situational
