Electric (Utility): Cost of electricity usage for your apartment.	Usage-based	Per unit / month	Required

Pet Deposit (Refundable): Deposit to cover any pet-related damage.	\$250	Per pet / one-time	Optional

Late Fee: Penalty for rent or fee payments made after the due date.	\$10	Per occurrence	Situational
Lease Non-Compliance Fee: Fee for non-compliance with lease terms or community policies.	Varies	Per occurrence	Situational
Legal / Eviction Fee: Costs associated with an eviction proceeding.	Varies	Per occurrence	Situational
Lock Replacement: Charge for lock replacement or rekeying residential lock.	\$35 - \$125	Per occurrence	Situational
Non-Sufficient Funds (NSF): Charge for returned payments due to non-sufficient funds.	\$25	Per occurrence	Situational
Reletting Fee: An expense associated with re-renting a unit after early lease termination.	Varies	Per occurrence	Situational
Security Deposit Additional (Refundable): Extra refundable deposit for added risk, damages, or lease conditions.	\$500	Per unit / one-time	Situational
Smoking Violation Fee: For non-compliance with community smoking policy.	Up to \$500	Per occurrence	Situational
Vacant Cost Recovery (Utility): Utility costs incurred while the unit was occupied by resident.	Usage-based	Per occurrence	Situational
