Improper Notice Fee: Charge for not providing proper advance notice before move-out.	Varies	Per occurrence	Situational
Transfer Unit Fee: Charge for transferring to another home within the same community.	\$150.00	Per occurrence	Situational
Late Fee: Penalty for rent or fee payments made after the due date.	10% of rent	Per occurrence	Situational
Lease Non-Compliance Fee: Fee for non-compliance with lease terms or community policies.	Varies	Per occurrence	Situational
Legal / Eviction Fee: Costs associated with an eviction proceeding.	Varies	Per occurrence	Situational
Lock Replacement: Charge for lock replacement or rekeying residential lock.	\$50.00	Per occurrence	Situational
