Access Card Fee: Electronic or physical key for secure entry to the community and/or home.	\$50	Per device / one-time	Required

Amenity / Clubhouse Rental Fee: Fee for reserving the community clubhouse for events or gatherings.	\$350	Per hour / occurrence	Optional
AC Window Rental: Fee for rental of portable AC window unit.	\$100	Per month / occurrence	Optional
Garage Structure (Parking Rent): Charge for access to a garage space in large parking garage structure.	\$300	Per item / month	N/A
Additional Space (Parking Rent): Charge for additional parking space on site.	\$400	Per vehicle / month	Optional
Pet Deposit (Refundable): Deposit to cover any pet-related damage.	\$250	Per pet / one-time	Optional

Lock Replacement: Charge for lock replacement or rekeying residential lock.	\$35 - \$125	Per occurrence	Situational
Non-Sufficient Funds (NSF): Charge for returned payments due to non-sufficient funds.	\$25	Per occurrence	Situational
Reletting Fee: An expense associated with re-renting a unit after early lease termination.	Varies	Per occurrence	Situational
Renter's Insurance Non-Compliance Fee: Fee for not maintaining required renter's liability insurance coverage.	\$50	Per occurrence / month	Situational
Security Deposit Additional (Refundable): Extra refundable deposit for added risk, damages, or lease conditions.	\$1,000	Per unit / one-time	Situational
Smoking Violation Fee: For non-compliance with community smoking policy.	Up to \$500	Per occurrence	Situational
Vacant Cost Recovery (Utility): Utility costs incurred while the unit was occupied by resident.	Usage-based	Per occurrence	Situational
