Application Fee: Fee to process rental application and background check.	\$10	Per application / one-time	Required
Security Deposit (Refundable): Refundable deposit covering potential damages and unpaid rent per lease terms.	\$350	Per unit / one-time	Required

Electric (Utility): Cost of electricity usage for your apartment.	Usage-based	Per unit / month	Required

Amenity / Clubhouse Rental Deposit (Refundable): Refundable deposit for potential damages during a clubhouse rental.	\$100	Per occurrence	optional
Amenity / Clubhouse Rental Fee: Fee for reserving the community clubhouse for events or gatherings.	\$50	Per hour / occurrence	optional
Pet Deposit (Refundable): Deposit to cover any pet-related damage.	\$250	Per pet / one-time	Optional
Pet Rent: Monthly charge for keeping a pet in the home.	\$25	Per pet / month	Optional
Pet Screening Fee: Fee paid to PetScreening for pet profile management (<i>Fee waived for assistance animals</i>).	\$30	Per pet / year	Optional

Access Card Fee Replacement: Charge to replace lost or damaged key, fob, remote, or lost parking permit.	\$50	Per occurrence	Situational
Concession Repayment: Tenant repayment of rent discounts if lease terms are not met.	Varies	Per occurrence	Situational
Early Lease Termination Fee: Fee for ending lease agreement before its scheduled end date.	1.5x Rent	Per occurrence	Situational

Improper Notice Fee: Charge for not providing proper advance notice before move-out.	Varies	Per occurrence	Situational
Late Fee: Penalty for rent or fee payments made after the due date.	\$50	Per occurrence	Situational
Lease Non-Compliance Fee: Fee for non-compliance with lease terms or community policies.	Varies	Per occurrence	Situational
Legal / Eviction Fee: Costs associated with an eviction proceeding.	Varies	Per occurrence	Situational
Lock Replacement: Charge for lock replacement or rekeying residential lock.	\$35 - \$125	Per occurrence	Situational
Non-Sufficient Funds (NSF): Charge for returned payments due to non-sufficient funds.	\$25	Per occurrence	Situational
Parking Lost Permit Fees: Fee for parking permit replacement	\$15	Per occurrence	Situational
Pet / Animal Violation Fee: Fee issued for unauthorized pets or violations of pet policy.	Varies	Per occurrence	Situational
Reletting Fee: An expense associated with re-renting a unit after early lease termination.	Varies	Per occurrence	Situational
Security Deposit Additional (Refundable): Extra refundable deposit for added risk, damages, or lease conditions.	\$500	Per unit / one-time	Situational
Smoking Violation Fee: For non-compliance with community smoking policy.	Up to \$500	Per occurrence	Situational
Vacant Cost Recovery (Utility): Utility costs incurred while the unit was occupied by resident.	Usage-based	Per occurrence	Situational
Non-transferred Utility Fee (Utility): Admin fee for utility costs not moved to resident's name.	\$50.00	Per occurrence	Situational
