Required Home Essentials <i>Fixed</i>		<i>The below costs are required as part of every rental application.</i>	
Access Card Fee: Electronic or physical key for secure entry to the community and/or home.	\$50.00	Per device / one-time	Required

Electric (Utility): Cost of electricity usage for your apartment.	Usage	Per unit / month	Required

Access Card Fee Replacement: Charge to replace lost or damaged key, fob, remote, or lost parking permit.	\$50.00	Per occurrence	Situational
Concession Repayment: Tenant repayment of rent discounts if lease terms are not met.	Varies	Per occurrence	Situational
Early Lease Termination Fee: Fee for ending lease agreement before its scheduled end date.	2x monthly rent	Per occurrence	Situational
Improper Notice Fee: Charge for not providing proper advance notice before move-out.	Full 30 days notice charge	Per occurrence	Situational
Transfer Unit Fee: Charge for transferring to another home within the same community.	TBD	Per occurrence	Situational
Late Fee: Penalty for rent or fee payments made after the due date.	\$80.00	Per occurrence	Situational
Lease Non-Compliance Fee: Fee for non-compliance with lease terms or community policies.	Varies	Per occurrence	Situational

Parking Lost Permit Fee: Fee for parking permit replacement.	\$50.00	Per occurrence	Optional
Parking Violation Fee: Fee for non-compliance with lease terms or community policies related to parking.	Varies	Per occurrence	Situational
Security Deposit Additional (Refundable): Extra refundable deposit for added risk, damages, or lease conditions.	Varies	Per unit / one-time	Situational
Smoking Violation Fee: For non-compliance with community smoking policy.	Varies	Per occurrence	Situational
Trash Violation Fee: Charge for non-compliance of community trash policy.	Varies	Per occurrence	Situational
