Lock Replacement: Charge for lock replacement or rekeying residential lock.	Up to \$125	Per occurrence	Situational
Non-Sufficient Funds (NSF): Charge for returned payments due to non-sufficient funds.	\$25	Per occurrence	Situational
Parking Violation Fee: Fee for non-compliance with lease terms or community policies related to parking.	Varies	Per occurrence	Situational
