Lock Replacement: Charge for lock replacement or rekeying residential lock.	\$35 - \$125	Per occurrence	Situational
Non-Sufficient Funds (NSF): Charge for returned payments due to non-sufficient funds.	\$25.00	Per occurrence	Situational
Reletting Fee: An expense associated with re-renting a unit after early lease termination.	Varies	Per occurrence	Situational
